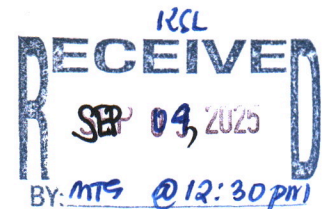



A BILL FOR AN ACT

To further amend State Law No. 13-98, as amended by State Law Nos. 13-103, 13-112, 13-119 and 13-120, by amending Section 4 at subsections (c) (d) to modify Office of the Kosrae State Legislature’s FY 2025 approved budget for Contractual and Others; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to further amend State Law No. 13-98, as
2 amended by State Law Nos. 13-103, 13-112, 13-119 and 13-120 by amending Section 4 at subsections
3 (c) (d) to modify the Kosrae State Legislature’s FY 2025 approved budget for Contractual and Others.

4 Section 2. Amendment. State Law No. 13-98, Section 4 is hereby amended to read as follows:

5 “Section 2. Apportionment. Operation of the Legislative. The sums apportioned by
6 Section 3 of this Act are apportioned as follows:

13 Section 3. Effective Date: This act takes effect upon the approval of the Governor or




