
A RESOLUTION

Urging Members of the Twenty +First Congress of the Federated States of Micronesia to immediately conduct an investigation or hearing concerning the under representation of Kosrean residents eligible to be appointed to the boards of independent government agencies and bodies including FSM Petrol Corp, FSM Vital Board, FSM Social Security Board, FSM Telecom Board, FSM Legal Service Board and FSM MiCare, the terms of reference for such investigation or hearing to include amending legislation governing the appointment of members of boards to government agencies or bodies to ensure as far as practicable and fairly that Kosrean residents eligible to be appointed to such boards are so appointed.

1 **WHEREAS**, members of the Twelfth Kosrae State Legislature perceive that Kosrae
2 State is inadequately represented by Kosrean residents eligible to be appointed to the boards of
3 FSM independent government agencies and bodies including FSM Petrol Corp, FSM Vital
4 Board, FSM Social Security Board, FSM Telecom Board, FSM Legal Service Board and FSM
5 MiCare and in turn perceive that a result of such under representation the interests and concerns
6 of the Kosrae State and its residents are not fairly addressed and taken into account ;and

7 **WHEREAS**, the members of the Twelfth Kosrae State Legislature further perceive that
8 it is necessary that any legislation governing the appointment of members to boards of
9 independent government agencies or bodies including FSM Petrol Corp, FSM Vital Board, FSM
10 Social Security Board, FSM Telecom Board, FSM Legal Service Board and FSM MiCare be
11 amended to ensure as far as practicable and fairly that Kosrean residents eligible to be appointed
12 to the boards of such government agencies or bodies are so appointed to ensure that Kosrean
13 residents are adequately represented on such boards; **NOW AND THEREFORE**
