

A BILL FOR AN ACT

To amend State Law No. 12-190, by amending Section 2 at subsection (b) to modify the Governor’s Office approved budget for Travel; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 12-190, by
2 amending Section 2 at subsection (b) to modify the Governor’s Office approved budget for
3 Travel under Local Revenue; and for other purposes.

4 Section 2. Amendment. State Law No. 12-190, Section 2 at subsection (b) is hereby
5 amended to read as follows:

6 “Section 2. Apportionment. Operation of the Executive. The sums appropriated
7 by Section 1 of this act are apportioned as follows....
