L. B. No. 13-211

A BILL FOR AN ACT

To appropriate the sum of \$62,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of subsidizing the operations of the Kosrae Port Authority; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$62,000.00 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the
3 purpose of subsidizing the operations of the Kosrae Port Authority.

4 Section 2. Apportionment. The amount shall be apportioned as follows:

5 (1) Training/ Travel	\$30,000.00
6 (2) Consumables	\$20,000.00
7 (3) Fixed Assets	\$12,000.00

8 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
9 managed, administered and accounted for in accordance with applicable laws. The allottee of
10 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
11 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
12 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

13 Section 4. Effective Date. This act shall become law upon approval by the Governor or
14 upon its becoming law without such approval.

15 PASSED BY THE 13TH KOSRAE STATE LEGISLATURE ON THE 8TH DAY OF JULY, 2025.

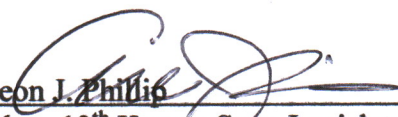

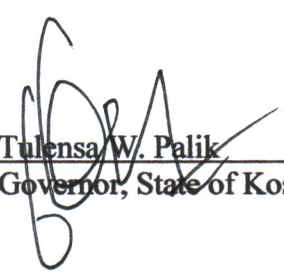
