



A BILL FOR AN ACT

To appropriate the sum of \$11,000 from the Revenue Fund of the Kosrae State Treasury for the Fiscal Year ending September 30, 2026 to provide funding assistance to the 2025 Annual Basketball Hoop slated for December 2025; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The amount of \$11,000 is hereby appropriated from the Revenue  
2 Fund of the Kosrae State Treasury for the Fiscal Year ending September 30, 2026, to provide funding  
3 assistance to the 2025 Annual Basketball Hoop slated for December 2025.

4           Section 2. Apportionment. The sum appropriated shall be apportioned as follows:

5                   1. Accommodation: \$2,380.00

6                           A.  $\$85 \text{ per day} \times 2 \text{ units} = \$170 \times 14 \text{ days} = \$2,380.00$

7                   2. Ground Transportation: \$1,960.00

8                           A.  $\$70 \text{ per day} \times 2 \text{ units} = \$140.00 \times 14 \text{ days} = \$1,960$

9                   3. Allowance: \$6,000.00

10                           A.  $\$400 \text{ per person} \times 15 \text{ participants} = \$6,000.00$

11                   4. Meals: \$660.00

12           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
13 administered and accounted for in accordance with applicable laws. The allottee of the funds  
14 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that



1 these funds, or so much thereof as may be necessary, are used for the purpose for which are  
2 appropriated and that no obligations are incurred in excess of the sum appropriated.

3 Section 3. Effective Date. This act shall become law upon approval by the Governor or upon  
4 its becoming law without such approval.
