A BILL FOR AN ACT

To further amend State Law No. 12-190, as amended by State Law Nos. 13-04, 13-07, 13-15, 13-22 and 13-23, by amending Section 10 at subsections 2(b), (c) and (d) to modify KIRMA's approved budget from the Local Revenue Fund by reclassifying funds under Contractual object class to the Travel and Consumable object classes; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 12-190, as
2 further amended by State Law Nos. 13-04, 13-07, 13-15, 13-22 and 13-23, by amending Section
3 10 at Subsection 2(b), (c) and (d) to modify KIRMA's approved budget from the Local Revenue
4 Fund by reclassifying funds under the Contractual object class to the Travel and Consumable
5 object classes.

6 Section 2. Amendment. State Law No. 12-190, Section 10 at subsection 1 (b), (c) and
7 (d) is hereby amended to read as follows:

8 "Section 2. Apportionment. Operation of the Executive. The sums appropriated by
9 Section 1 of this act are apportioned as follows:
