

A BILL FOR AN ACT

To appropriate the sum of \$3,000.00 (donation from Da Yang) from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the 2024 Micro Games in RMI; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$3,000.00 (donation from Da Yang) is hereby
2 appropriated from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the
3 2024 Micro Games.

4 Section 2. Apportionment. The amount shall be apportioned as follows:

5 1. 2024 Micro Games in RMI \$3,000.00

6 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
7 managed, administered, and accounted for in accordance with applicable laws. The allottee of the funds
8 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that
9 these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated
10 and that no obligations are incurred in excess of the sum appropriated.

11 Section 5. Effective Date. This act takes effect upon the approval of the Governor or upon its
12 becoming law without such approval.
