

L. B. No. 13-08

A BILL FOR AN ACT

To appropriate the sum of \$17,250.00 from the US Federal Grant of the Kosrae State Treasury for the purpose of funding the Kosrae –PMHCA23 program in the state; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$17,250.00 is hereby appropriated from the US
2 Federal Grant of the Kosrae State Treasury for the purpose of funding the Kosrae –PMHCA23.

3 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
4 managed, administered and accounted for in accordance with applicable laws. The allottee of
5 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
6 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
7 which are appropriated and that no obligations are incurred in excess of the sum appropriated.
8 The authority of the allottee to obligate the fund appropriated by this act shall be lapsed on
9 September 29, 2023.

10 Section 3. Effective Date. This act shall become law upon approval by the Governor or
11 upon its becoming law without such approval.
