## A RESOLUTION

Expressing approval and endorsing of the 2023 Agreement between the Government of the United States of America and the Government of the Federated States of Micronesia, to Amend the Compact of Free Association, as amended, and its subsidiary agreements, namely the 2023 Fiscal Procedures Agreement and the 2023 Compact Trust Fund Agreement.

1 WHEREAS, pursuant to law, the Joint Committee on Compact Review and Planning 2 (JCRP) negotiated Agreement between the Government of the United States of America and Government of the Federated States of Micronesia to Amend the Compact of Free Association, 3 4 as amended ("2023 Amended Compact"); and 5 WHEREAS, the JCRP also negotiated subsidiary agreements for the 2023 Amended Compact that have been concluded so far, as follows: Agreement Concerning Procedures for the 6 Implementation of United States Economic Assistance Provided in the 2023 Amended Compact 7 between the Government of the United States of America and the Government of the Federated 8 States of Micronesia, as amended ("2023 Fiscal Procedures Agreement"), and 9 Agreement between the Government of the United States of America and the Government of the 10 Federated States of Micronesia Regarding the Compact Trust Fund ("2023 Compact Trust Fund 11 12 Agreement"); and 13 WHEREAS, the President authorized the transmittal of the 2023 Amended Compact for ratification by the FSM Congress; and the President further transmitted the subsidiary 14 agreements to the 23<sup>rd</sup> FSM Congress for information purposes; and 15
