BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE


1 Section 1. Purpose. The purpose of this act is to amend the Kosrae State code by  
2 repealing section 13.703(30) of Title 13.


3 Section 2. Amendment. Title 13, Chapter 7, Section 13.703(30) of the Kosrae  
4 State Code is hereby repealed:

5 Section 3. Effective Date. This act takes effect upon the approval of the Governor  
6 or upon its becoming law without such approval.
