

A BILL FOR AN ACT

To amend State Law No. 13-40, by amending the effective date of the salary increase for public service system employees authorized by law, from January 1st, 2024 to be subjected upon availability of secured funding; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 13-40, by
2 amending the effective date of the salary increase for public service system employees authorized
3 by law from January 1st, 2024 to subject upon availability of secured funding.

4 Section 2. Amendment. Section 3 of State Law No. 12-190 is hereby amended to read as
5 follows:

6 “Section 3. Effective Date. Upon approval of the Governor or upon its becoming law
7 without such approval, this act shall become effective as soon as funding is secured and made
8 available.”
