#### A BILL FOR AN ACT

To amend Title 6 of the Kosrae State Code by amending Section 6.1601 to change weekly deposit to daily deposit in the State Revenue Fund fines and fees received by the court; and for other purposes.

# BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by 1 amending Section 6.1601 of Title 6, to change weekly deposit to daily deposit in the State 2 Revenue Fund fines and fees. 3 Section 2. Amendment. Title 6, Chapter 16, Section 6.1601 of the Kosrae State 4 Code is hereby amended to read as follows! 5 Section 6.1601. Fines and fees. "The Court transmits daily to the Office of 6 Finance and Treasury for deposit in the State Revenue Fund fines and fees received by the 7 Court, except fees received as payment for published decisions, opinions, rules, probation 8 fees, or other documents issued by the Court". 9 Section 3. Effective Date. This act takes effect upon the approval of the Governor 10 or upon its becoming law without such approval. 11 12
