This being the seat of Government put me in direct oversight of all affairs of this island-state and its citizens. It was an unprecedented joy and honor. During these two terms many major infrastructure projects were brought to the front and implementations started. A short list of these included road pavements, numerous new offices, elementary, and high school classrooms were approved, and funded with some constructions implemented. Additionally new education policies, environmental laws, and regulations were passed and put to use. Deficits were drastically improved from previous periods during this time.

Duties in this assignment included advising, and offering expert analyses to the Assistant Secretary of Customs and Tax, and the Secretary of The Department of Finance on all tax matters. It was also part of this assignment to review and institute administrative changes to improve revenue collections. Tax revenues have been on an upward trend, credit to changes which have been implemented during this period. Manuals of Operation, Standard Operational Procedures (SOP's) required under this assignment have already been started to get published with still more envisioned/planned to be produced. Additionally a major overhaul of the entire CTA workforce was effectuated during this period addressing pay structures, and duties. Appropriate cross training of staffs to be responsive to this change have started, including establishing an MBO approach to most of the work in this office.

This post provided an opportunity for me run a power operation side by side with expatriate professionals in the field. Two most major shifts occurred during this period: (1) a major upgrade to larger engines effectively increasing fuel efficiency, and dependability; (2) delinquency problems dropped drastically for payers of electricity after a new campaign to collect debts was executed during this period. Additionally local staffs were trained in assembling and installing the larger engines (above) localizing expertise for KUA.

Computerization and general modernization of all financial processes began this period when former TTPI dispersed and passed on all financial duties to the different Governments in Micronesia. The first audit laws, and our Financial Management Act were among milestones created for Kosrae during this period formalizing accounting requirements. All these were provided with satisfaction.

Issue:

Whether or not it is legal to have more than one Justice Pro Tempore?

The applicable law to the subject matter issue is Section 6.1204 of the Kosrae State Code of Laws. It states in its entirety:

"Section 6.1204. Justice pro tempore.

- (1) The Court proposes to the Legislature a person with the qualifications of a justice for the Legislature's approval by resolution of the Legislature to be available to serve as a justice pro tempore for a period of one year.
- (2) The Court may appoint only an approved person as a justice pro tempore to exercise the powers of a justice in an action for which a justice is not lawfully available.
- (3) Appointment is pursuant to a <u>method of regular rotation</u> established by rule.
- (4) Unless a justice pro tempore dies, becomes disabled, resigns, or is absent from the State on non-judicial matters for three months, or his term expires, an appointment once made continues in effect until the entry of a final judgment or order in the designated matter and the expiration of the time for filing of a post-trial motion, or until final disposition of a post-trial motion. If, upon remand after appeal the same person is eligible for appointment as justice pro tempore, he continues as justice pro tempore in that matter. (emphasis added)"

Subsection (1) of 6.1204 prescribed the legal avenue which the Court is required to take in order to secure a Justice pro tempore. That avenue is through the approval of the legislature of a person with the qualification of a justice.

Subsection (2) of 6.1204 limits the authority of the Court to appoint a Justice pro tempore to only those that have been approved by the Legislature through the legal avenue prescribed under Subsection (1).

Subsection (3) of 6.1204 speaks of the authority conferred to the Court to establish by Rule a method of regular rotation of appointment of Justice pro tempore.

The emphasis of Subsection (4) of 6.1204 is on the term or tenure of an appointment of a Justice pro tempore and the situations and/or events that may actuate the end of a tenure or appointment of a Justice pro tempore.

There is no explicit provision restricting the Court to have more than one Justice pro tempore. Additionally, there are pivotal implications from phrases like "method of regular rotation" for appointment by the Court of Justice pro tempore and appointment once made continues in effect until the entry of a final judgment or order in the designated matter", that one can reasonably deduce that the Court may appoint a Justice pro tempore for a particular case based on the area of expertise or experience. Put in another way, two or three Justices pro tempore may be appointed to deal with three different cases and appointment could be at the same time or otherwise based on the method of rotation and rules established by the Court.

The analysis above is consistent with certain legal principles, doctrines, or constitutional rights enshrined in our Constitutions to guide the duties, functions, mandates, and services of a judiciary system. For instance, the Right to Speedy Trial, Equal Protection of the Law, Due Process, and many others. It falls squarely within the ambit of the legal responsibility of the court to ascertain its judicial process, procedures, and capacity to effectively and efficiently adjudicate cases.

In short, it is legal for Kosrae State Court to have more than one Justice pro tempore. Feel free to contact me should you have any questions in connection herewith.
