A BILL FOR AN ACT

To appropriate the sum of \$15,000.00 from the Local Revenue Fund of the Kosrae State Treasury to support the Professional Competency Development & Training of the Kosrae State Office of the Public Auditor; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$15,000.00 is hereby appropriated from the Local  
2 Revenue Fund of the Kosrae State Treasury for the purpose of supporting the Professional  
3 Competency Development & Training of the Kosrae State Office of the Public Auditor (OPA).

4           Section 2. Apportionment. The amount hereby appropriated shall be apportioned as  
5 follows:

7           Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,  
8 managed, administered and accounted for in accordance with applicable laws. The allottee of  
9 the fund appropriated shall be the Public Auditor of the State of Kosrae. The allottee shall be  
10 responsible for ensuring that these funds are used for the purposes for which are appropriated  
11 and that no obligations are incurred in excess of the sum appropriated. The allottee shall have  
12 the authority to obligate the grant funding appropriated by this act until such fund is fully  
13 expended or its period of availability is extended or otherwise expired according to the terms and  
14 conditions of the grant.



ARTICLE FOUR

To appropriate the sum of \$15,000 from the Local Revenue Fund of the Kansas State Treasury to support the Professional Competency Development & Training of the Kansas State Office of the Public Auditor and for other purposes.

BE IT ENACTED BY THE KANSAS STATE LEGISLATURE

Section 1. Appropriation. The sum of \$15,000.00 is hereby appropriated from the Local Revenue Fund of the Kansas State Treasury for the purpose of supporting the Professional Competency Development & Training of the Kansas State Office of the Public Auditor (O.P.A.).

Section 2. Appropriation. The amount hereby appropriated shall be appropriated as follows:

(1) O.P.A. Professional Competency Development & Training \$15,000.

Section 3. Appropriation and Disbursement. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws. The allottee of the fund appropriated shall be the Public Auditor of the State of Kansas. The allottee shall be responsible for ensuring that these funds are used for the purpose for which are appropriated and that no obligations are incurred in excess of the sum appropriated. The allottee shall have the authority to obligate the grant fund(s) appropriated by this act and each fund is only expended or its period of availability is extended or otherwise expended according to the terms and conditions of the grant.

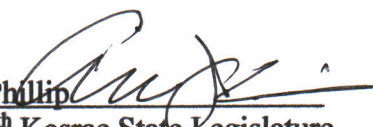

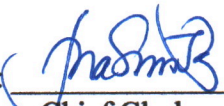
