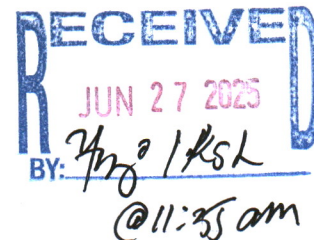

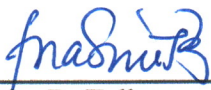

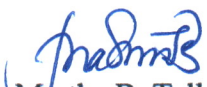

A BILL FOR AN ACT

To appropriate the sum of \$15,000.00 from the Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of providing Kosrae State's financial contribution to the Micronesian Legal Services Corporation (MLSC) for its continuous services to the region and the people; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$15,000.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025
3 for the purpose of providing Kosrae State's financial contribution to the Micronesian
4 Legal Services Corporation (MLSC) for its continuous services to the region and the
5 people.

6 Section 2. Apportionment. The amount appropriated in Section 1 of this act is
7 apportioned as follows:

8 1. Micronesian Legal Services Corporation (MLSC) \$15,000.00

9 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
10 administered, and accounted for in accordance with applicable laws. The allottee of the
11 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
12 for ensuring that these funds, or so much thereof as may be necessary, are used for the
13 purpose for which are appropriated and that no obligations are incurred in excess of the
14 sum appropriated.

15 Section 4. Effective Date. This act takes effect upon the approval of the Governor
16 or upon its becoming law without such approval.

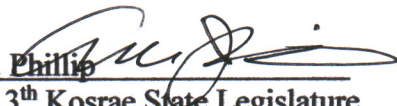

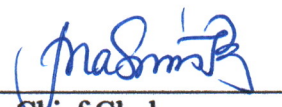

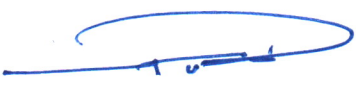
