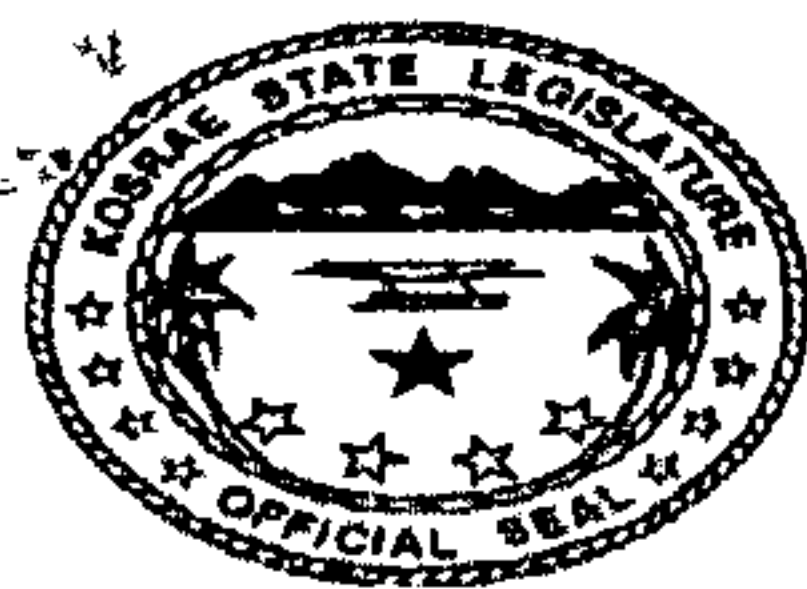

A BILL FOR AN ACT

To amend State Law No. 13-41, by extending the lapse date; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to extend the lapse on State Law No, 13-  
2 41.

3           Section 2. Amendment. State Law No. 13-41 is hereby amended to read as follows:

4                   “...Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be  
5 allotted, managed, administered and accounted for in accordance with applicable laws.  
6 The allottee of the fund appropriated shall be the Governor of the State of Kosrae, who  
7 shall be responsible for ensuring that these funds, or so much thereof as may be  
8 necessary, are used for the purpose for which are appropriated and that no obligations are  
9 incurred in excess of the sum appropriated. The authority of the allottee to obligate the  
10 fund appropriated by this act shall be extended until expended.”

11           Section 3 Effective Date. This act shall become law upon approval by the Governor or  
12 upon its becoming law without such approval.


