A BILL FOR AN ACT

To amend State Law No. 12-75, as further amended by State Law No. 12-193, to reflect a modification of \$8,000.00 supplementing a shortfall on the UCF Coordinator's salary covering up to September 20, 2024; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to modify State Law No. 12-75, at
2 Section 2(3) by supplementing \$8,000.00 shortfall on the UCF Coordinator's salary up to
3 September 20, 2024.

4 Section 2. Amendment. State Law No. 12-75, as further amended by State Law
5 12-193 is hereby amended at Section 2(2) to read as follows:

6 ...Section 2. Appropriation. The amount of \$137,032.00 of this act is apportioned
7 as follows:


