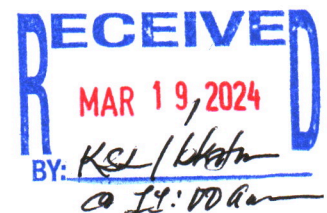

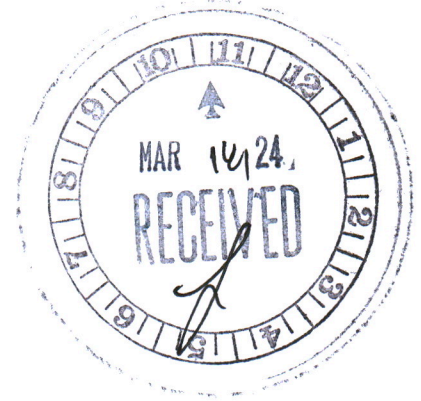



A BILL FOR AN ACT

To amend the Kosrae State Code by amending Chapter 2 of Title 5, by inserting a new Section 5.211, to designate and rename the Kosrae State-owned public tennis court as the Sterling N. Skilling Memorial Tennis Court; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by amending
2 Chapter 2 of Title 5, by inserting a new Section 5.211, to designate and rename the Kosrae State-owned
3 public tennis court as the Sterling N. Skilling Memorial Tennis Court; and for other purposes.

4 Section 2. Amendment. Title 5, Chapter 2, Section 5.211 of the Kosrae State Code is hereby
5 inserted to read as follows:



9 Section 5.211. Sterling N. Skilling Memorial Tennis Court.


10 The Kosrae State-owned tennis court shall be known as the Sterling N. Skilling Memorial Tennis
11 Court.”


12 Section 3. Effective Date. This act shall become law upon approval by the Governor or upon its
