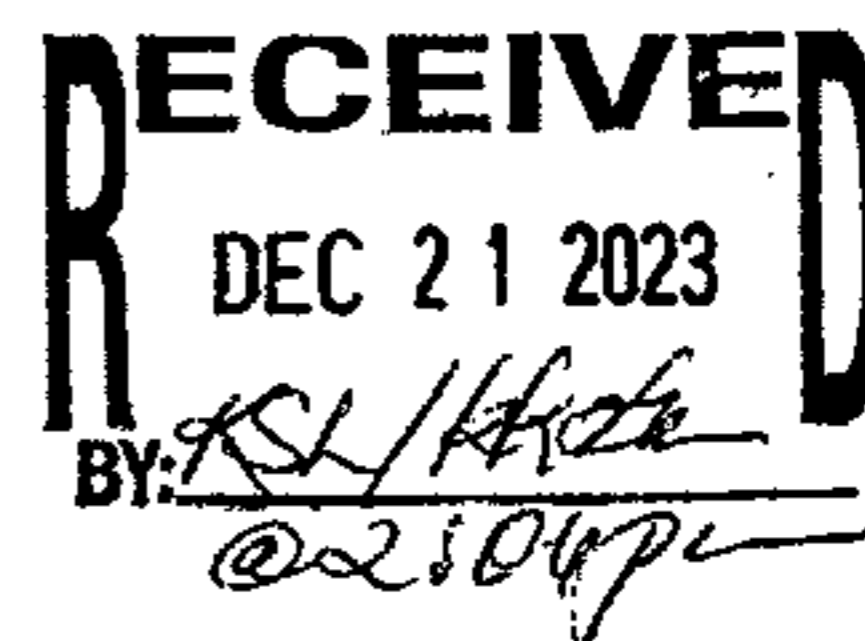



Everyone's cooperation and support to this designation is requested and will be appreciated.

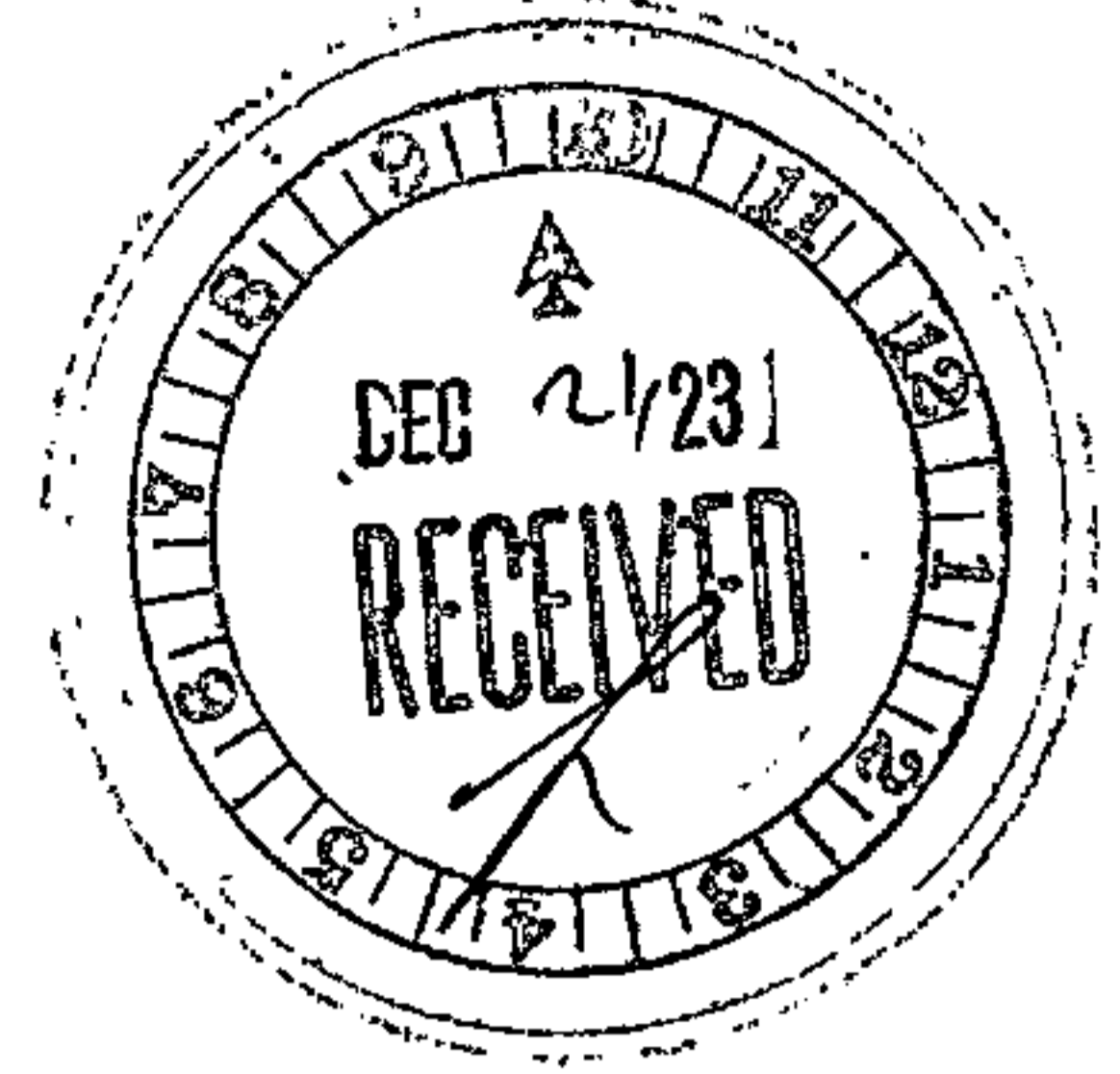

A BILL FOR AN ACT

To appropriate the sum of \$6,000 from the Local Revenue Fund of the Kosrae State Treasury to subsidize the Utwe Water System in purchasing the supplies and materials necessary to maintain from the main water system to the households in Utwe; and for other purposes.


BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$6,000.00 from the Local Revenue Fund of the
2 Kosrae State Treasury is appropriated to subsidize the Utwe Water System in funding the
3 supplies and materials necessary to maintain from the main water system to the households in
4 Utwe.

5 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
6 managed, administered and accounted for in accordance with applicable laws. The allottee of
7 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
8 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
9 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

10 Section 3. Effective Date. This act shall become law upon approval by the Governor or
11 upon its becoming law without such approval.


