A BILL FOR AN ACT

To appropriate the sum of \$1,500.00 from the Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2026 for the purpose of providing funding assistance for the Special Election scheduled to be held in the Malem Municipal Government in November, 2025; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$1,500.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2026
3 for the purpose of providing funding assistance for the Special Election scheduled to be
4 held in the Malem Municipal Government in November, 2025.

5 Section 2. Apportionment. The amount appropriated in Section 1 of this act is
6 apportioned as follows:

7	a. Election materials (ballots and specimen)	\$350.00
8	b. Election board stipends	\$900.00
9	c. Logistics and miscellaneous costs (incidentals)	\$250.00

10 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
11 administered, and accounted for in accordance with applicable laws. The allottee of the
12 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
13 for ensuring that these funds, or so much thereof as may be necessary, are used for the
14 purpose for which are appropriated and that no obligations are incurred in excess of the
15 sum appropriated.

16 Section 4. Effective Date. This act takes effect upon the approval of the Governor
17 or upon its becoming law without such approval.
