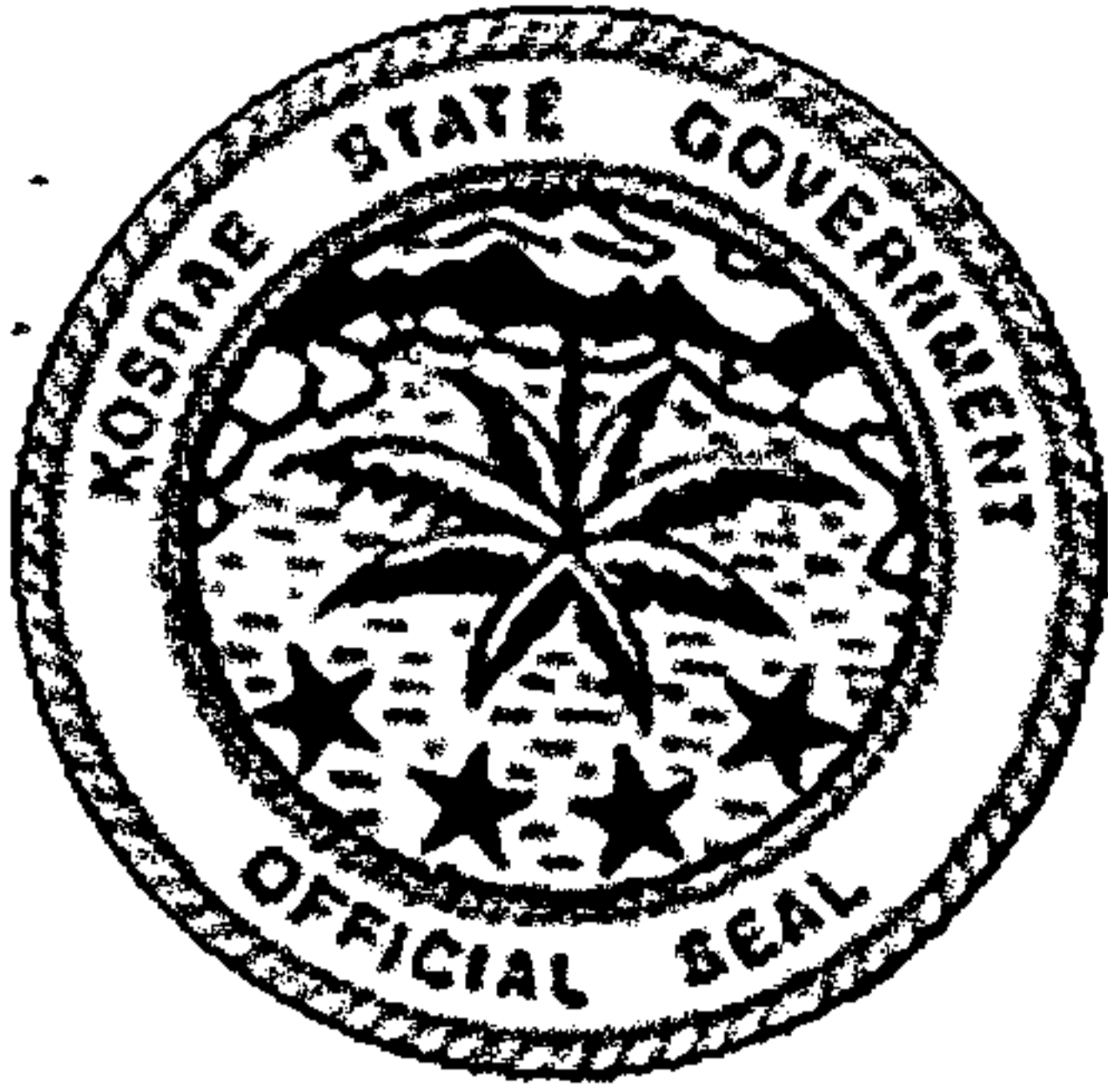

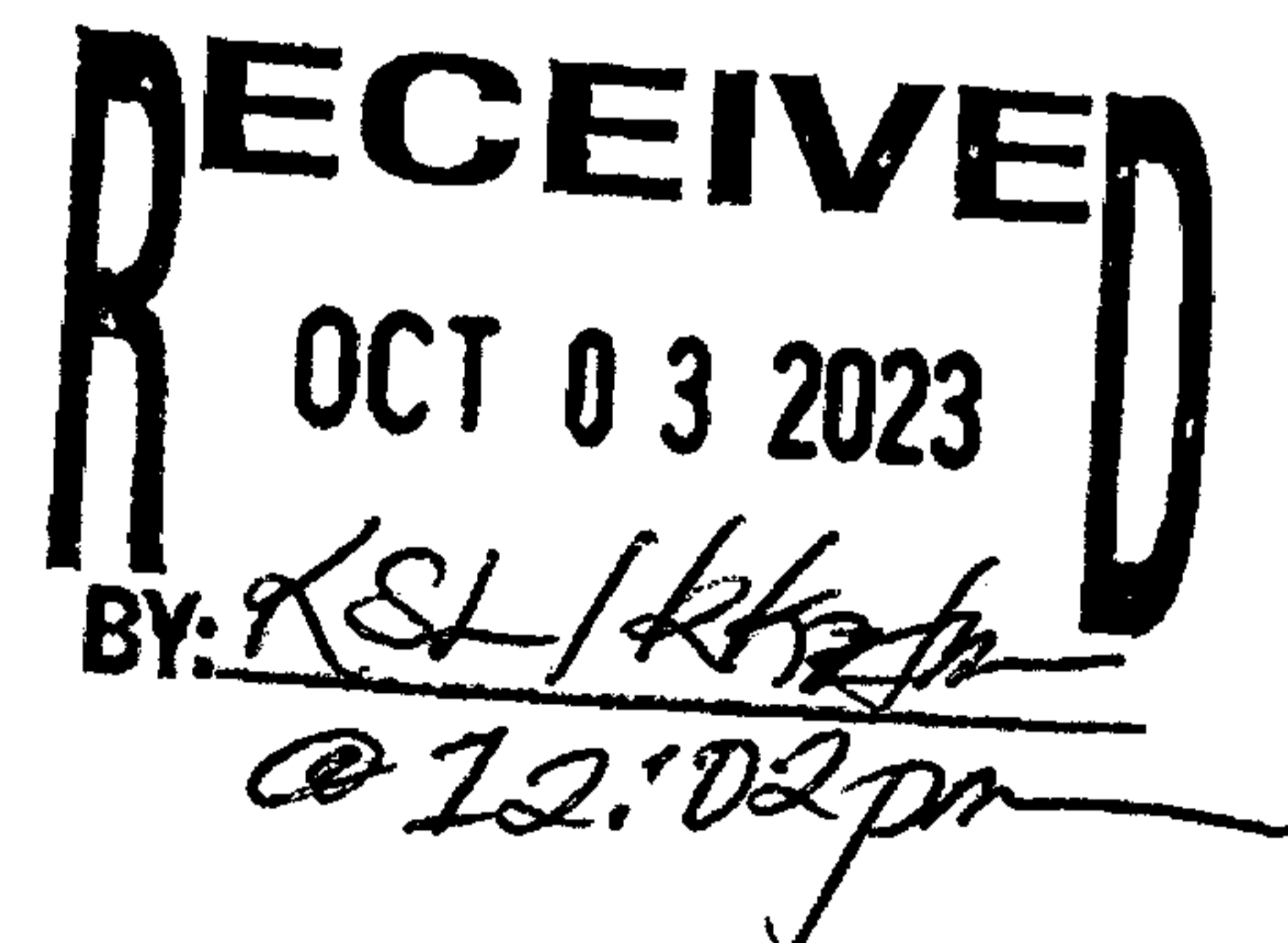

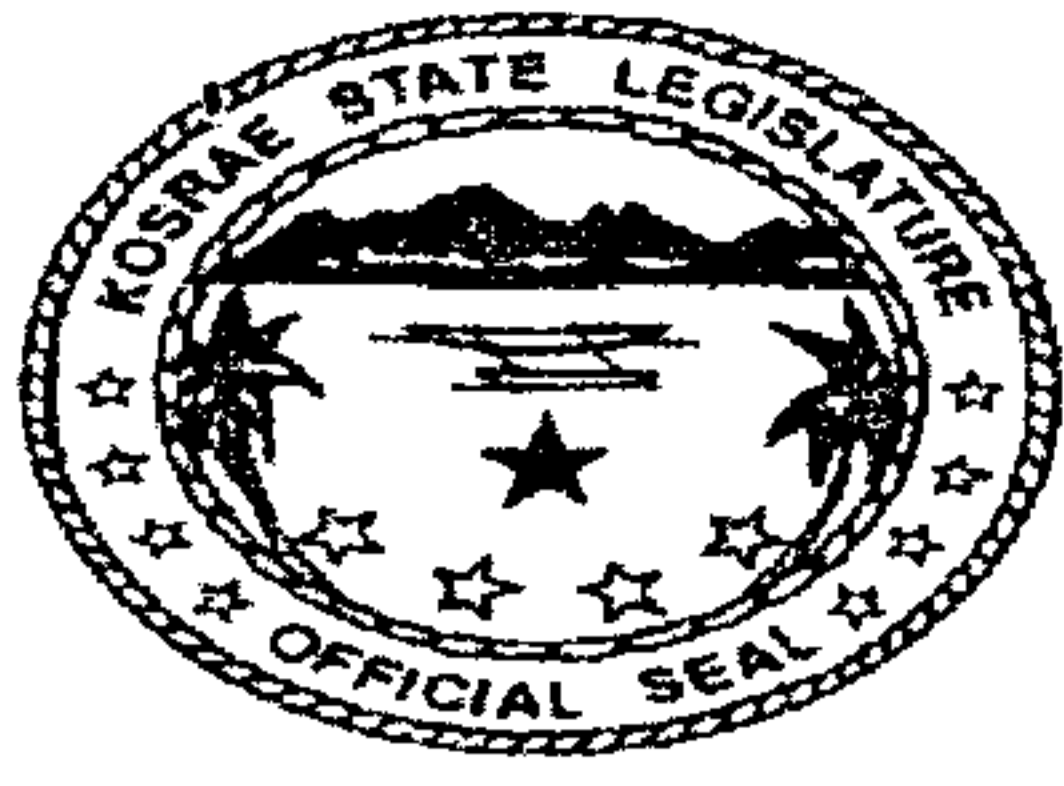

A BILL FOR AN ACT

To further amend State Law No. 12-190, as amended by State Law Nos. 13-04, 13-07, 13-15, 13-22, 13-23 and 13-26, by amending Section 10 at subsections (1)(a), (1)(b) and (1)(c), to redirect the travel budget for the Broadcast Authority to Contractual and Consumable budgets under the Local Revenue Fund; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 12-190, as
2 further amended by State Law Nos. 13-04, 13-07, 13-15, 13-22, 13-23, and 13-26, by
3 amending Section 10 at Subsections (1)(a), (1)(b), and (1)(c), to redirect the travel budget
4 for the Broadcast Authority to Contractual and Consumable budgets under the Local
5 Revenue Fund.

6 Section 2. Amendment. State Law No. 12-190, Section 10 at subsections (1)(a),
7 (1)(b), and (1)(c) are hereby amended to read as follows:

8 “...Section 10. Apportionment. Operation of Certain Agencies. The sums
9 apportioned by Section 9 of this act are apportioned as follows:


