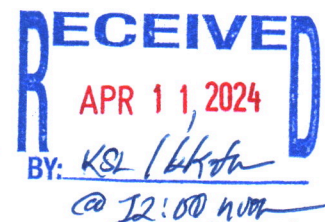

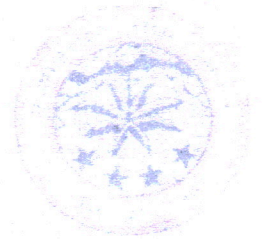



A BILL FOR AN ACT

To appropriate the sum of \$75,000 from the General Fund of the Kosrae State Treasury to cover the equity payment for the State of Kosrae balance to the PIDB.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum \$75,000 from the General Fund of the Kosrae State to fund
2 what the Kosrae State still owes to the PIDB.

3 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
4 managed, administered and accounted for in accordance with applicable laws. The allottee of the fund
5 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that
6 these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated
7 and that no obligations are incurred in excess of the sum appropriated and funds shall be used until
8 expended.

9 Section 4. Effective Date. This act shall become law upon approval by the Governor or upon its
10 becoming law without such approval.


