Dear Speaker Phillip:

Your Joint Committee on Ways & Means (W&M) and Environment, Transportation, Communication, and Infrastructure (ETC&I), to which was assigned L.B. No. 13-09 entitled, *"To appropriate the sum of \$40,000 from the Local Revenue Fund of the Kosrae State Treasury for the immediate fixing and reinforcement of the Mosral shoreline protection; and for other purposes,"* begs leave to report as follows:

COMMITTEE ACTION:

Your joint committee met in an Executive Meeting on May 22<sup>nd</sup>, 2023 and decided to dispose its action on L.B. No. 13-09.

COMMITTEE FINDINGS:

The intent of the subject proposal is clearly stated in its title.

The subject bill aims to provide funding support for the immediate fixing and reinforcement of the Mosral shoreline protection, which was perceived to be rapidly deteriorating at the time.

With discussions at a minimal during the joint committee's meeting on May 22<sup>nd</sup>, 2023, the members agreed to move forward with the bill, hoping that further discussions and additional information may be shared by other members during the plenary session.

COMMITTEE RECOMMENDATION:

With the aforementioned findings, Your Joint Committee on W&M and ETC&I hereby recommends the reporting out of L.B. No. 13-09.


