

A BILL FOR AN ACT

To appropriate the sum of \$41,532,163.00 from the Public Sector Infrastructure Fund of the Kosrae State Treasury for the purpose of funding the Kosrae Hospital; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$41,532,163.00 is hereby appropriated from
2 the Public Sector Infrastructure Fund of the Kosrae State Treasury for the purpose of
3 funding the Kosrae Hospital; and for other purposes.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in accordance with applicable law. The
6 allottee of the fund appropriated shall be the Governor of the State of Kosrae, who shall be
7 responsible for ensuring that these funds, or so much thereof as may be necessary, are
8 used for the purpose of which are appropriated and that no obligations are incurred in
9 excess of the sum appropriated. The authority of the allottee to obligate the fund
10 appropriated by this act shall be lapsed on September 30, 2027.

11 Section 3. Effective Date. This act takes effect upon the approval of the Governor
12 or upon its becoming law without such approval.
