A RESOLUTION

Consenting and confirming the nomination of Mr. Lyndon Cornelius to serve as a Board of Director for the Port Authority of the State of Kosrae.

WHEREAS, Section 7.601 of the Kosrae State Code establishes the Kosrae State 1 2 Port Authority; and WHEREAS, Section 7.606 of the Kosrae State Code further composes the Board 3 of Directors with five voting members. Four Directors; one from each of the four 4 Municipalities, appointed by the Governor with the advice and consent of the Legislature, 5 and, ex-officio, the Director of the Department of Transportation and Infrastructure. An 6 7 appointed Director serves for a term of four years, subject to reappointment, and until his successor has been appointed and qualifies. Initially, the Governor appoints two Directors 8 9 to two-year terms and two Directors to four-year terms; and 10 WHEREAS, thru Governor's Message 12-350 dated November 22, 2021, 11 Governor of Kosrae State, Carson K. Sigrah, has nominated Mr. Lyndon Cornelius to serve 12 as a member of the Kosrae State Port Authority; and WHEREAS, the Speaker of the 12th Legislature has assigned Governor's Message 13 14 12-350 to the Committee on Environment, Transportation, Communication, and 15 Infrastructure in which the committee has deliberated and concluded its work on the 16 nomination of Mr. Lyndon Cornelius; and 17 WHEREAS, it is the finding of the Standing Committee on Environment,
