A BILL FOR AN ACT

To amend Title 7 of the Kosrae State Code by amending Section 7.113, to increase the meeting compensation fee from \$20 to \$40 per meeting; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by  
2 amending Section 7.113, to increase the meeting compensation fee from \$20 to \$40 per  
3 meeting; and for other purposes.

4           Section 2. Amendment. Title 7, Chapter 1, Section 7.113 of the Kosrae State  
5 Code is hereby amended to read as follows:

6           “Section 7.113. Compensation of governing bodies.

7 A member of an agency governing body receives compensation at prescribed rates, which  
8 may not exceed \$40 per meeting, when they physically attend meetings of the body. This  
9 Section applies to all members of agency governing bodies and state appointed members  
10 of the government financed enterprises listed in Part II of this Title.”

11           Section 3. Effective Date. Upon approval of the Governor or upon its becoming  
12 law without such approval, this act shall become effective October 1<sup>st</sup>, 2023.
