**A RESOLUTION**

Consenting to and endorsing the 2024-2044 Kosrae State Strategic Development Plan.

1           **WHEREAS**, the Kosrae State Strategic Development Plan is a guiding mechanism for  
2 government policies, actions and investments, which was initially formulated and established in  
3 2014. This Strategic Development Plan has been developed collaboratively with the citizens and  
4 stakeholders of Kosrae, which serve as the basis for Kosrae State’s annual operational plans and  
5 budget for the next twenty years; and

6           **WHEREAS**, thru this updated Strategic Development Plan, the framework encompasses  
7 internal and external development aspirations which focuses on nine (9) thematic areas—  
8 (1)Governance and Institutional Strengthening; (2) Sustainable Economic Development; (3)  
9 Infrastructure Development and Sustainability; (4) Environmental Sustainability and Climate  
10 Resilience; (5) Health and Wellbeing; (6) Education and Human Capital Development; (7)  
11 Gender Equality and Social Inclusion; (8) Cultural Heritage; and (9) Peace and Security; and

12           **WHEREAS**, the Kosrae State Strategic Development Plan covers a twenty (20) year  
13 period beginningfrom 2024 thru 2044 and is designed to achieve the vision of a sustainable,  
14 well-governed, and socially equitable and vibrant Kosrae. It aims to empower the adoption of  
15 sustainable, inclusive, and resilient development framework, re-aligning itself with the Kosrae  
16 State Constitution, the National Strategic Development Plan and the United Nations Sustainable  
17 Development goals; and

1           **WHEREAS**, the Kosrae Strategic Development is developed through sharing approaches  
2 with wide-ranging involvement, input, and commitments from various levels of the Kosrae  
3 Leadership and stakeholders from the public sector, the private sector and the civil society; and

4           **WHEREAS**, the goals and the strategies on this Strategic Development Plan are based on  
5 the priorities of the Kosrae State Leadership and its stakeholders, which does not and should not  
6 take away outgoing efforts of the State and its various stakeholders; NOW & THEREFORE


7           **BE IT RESOLVED**, that the 13<sup>th</sup> Kosrae State Legislature during its Eighteenth Special
