## A RESOLUTION

CONSENTING TO THE RE-NOMINATION OF MR. LINSON WAGUK TO SERVE AS A MEMBER OF THE KOSRAE PRICE CONTROL COMMISSION.

1 WHEREAS, pursuant to Section 12 of Article V of the Kosrae State Constitution, the

2 Governor has the constitutional authority to appoint members comprising States Boards,

Authority, Commissions or Agencies with the advice and consent of the Legislature: and

WHEREAS, Section 7.1701 of title 7 of the Kosrae State Code established the Price

Control Commission to protect the people of Kosrae from price exploitation; and

WHEREAS, Section 7.1704 (1) and (2) of title 7 of the KSC to be composed of five members appointed by the Governor with the advice and consent of the Legislature. The members appointed shall be citizens residing in Kosrae State. The members appointed shall not include more than one person having a controlling ownership or a managerial interest in one or more businesses in Kosrae. The Director of the Department of Administration and Finance shall

be an ex-officio member of the Commission, without the right to vote. The the term of office of

the appointed members of the Commission shall be two years. Appointments to fill vacancies

shall be for the remainder of the unexpired term.

WHEREAS, by Governor Message No. 12-95, Honorable Governor Carson K. Sigrah

has re-nominated Mr. Linson Waguk to be a member of the Kosrae Price Control Commission;
