

A BILL FOR AN ACT

To further amend State Law No. 13-37, as amended by State Law Nos. 13-42, 13-48, and 13-60, by amending Section 4 at subsection (d) to modify the Kosrae State Legislature’s FY2024 approved budget for Consumables; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to further amend State Law No. 13-
2 37, as amended by State Law Nos. 13-42, 13-48, and 13-60, by amending Section 4 at
3 subsection (d) to modify the Kosrae State Legislature’s FY2024 approved budget for
4 Consumables.

5 Section 2. Amendment. State Law No. 13-47, Section 4 is hereby amended to
6 read as follows:

7 “Section 4. Apportionment. Operation of the Legislature. The sums
8 apportioned by Section 3 of this Act are apportioned as follows:

14 Section 3. Effective Date. This Act takes effect upon the approval of the Governor
15 or upon its becoming law without such approval.
