A RESOLUTION

Expressing the Twelfth Kosrae State Legislature's deepest sympathy to the passing of the late Mr. Tiser Reynold and conveying sincere condolences to wife, Mrs. Roslyn T. Reynold and family.

1           **WHEREAS**, the late Mr. Tiser Reynold was a native Chuukese married to Mrs. Roslyn  
2 Tiser Reynold, a hardworking wife, mother, and native of Lelu, Kosrae; and

3           **WHEREAS**, the late Mr. Tiser Reynold came to Kosrae with his wife to start a new  
4 family around the early 90's; and

5           **WHEREAS**, the late Mr. Tiser Reynold started serving Kosrae State Government as a  
6 Budget Analysis II in 1993; and

7           **WHEREAS**, during his time of active service, the late Mr. Tiser Reynold had been  
8 immediately recognized by the state government for his hard work and dedication, serving in  
9 numerous capacities, which included becoming the Budget Analysis III in 1995, later on as the  
10 Budget Analysis IV in the same year, then again promoted to serve as the Budget Officer in the  
11 year 1995; he eventually became the Administrator of the Budget Office in 2001; and

12           **WHEREAS** the late Mr. Tiser Reynold was later bestowed a higher task in the Kosrae  
13 State Government to serve the seat of directorship under the Department of Administration and  
14 Finance in the year of 2007 where he served for four years and resigned from the Directorship on  
15 11<sup>th</sup> day of January 2011 however, on the 12<sup>th</sup> day of January 2011, he was appointed to serve as  
16 a Transition Consultant under the Department of Administration and Finance, which in two  
17 months later he was appointed again to serve the seat of Director of Finance and Administration

1 in the same year of 2011, where he again served for two years and resigned from the Director's  
2 duty on the 30<sup>th</sup> day of March 2013; and

5 Roslyn Joseph Sigrah, and a father and role model to four God-fearing children namely Shirlyn,

8 recognition of his sacrifices and invaluable service representing the people and State of Kosrae,
