INVITATION FOR BIDS

Sealed bids for the DREA Piggery Rehab Project situated at Tofol, will be received by the Kosrae Project Management Office at the Transportation and Infrastructure office, until 10:00 A.M. on April 7, 2023, at which time the opening of the bids will take place and the bids will be publicly read aloud.

Electronic copies of the contract documents, detailed drawings and scope of works can be obtained from the Kosrae Project Management Office free of charge provided the prospective bidders will bring Memory Stick or Flash Drive for use in downloading of the aforementioned documents or provide an email address. Paper copies may be provided on request.

A pre-bid conference is scheduled on March 24, 2023 at 10:00 A.M., at the of the DREA Conference Room. A site visit will be held immediately following this meeting. Prospective bidders who do not attend the pre-bid shall be automatically disqualified to participate in the bidding process.

The bids must be submitted in a sealed envelopes bearing on the outside the name of the bidder, his address, the name of the project, and the date and time submitted. If forwarded by mail, the sealed envelope containing the bid shall be marked as directed above and must be enclosed in another envelope properly addressed with the notation "BID ENCLOSED" on the surface thereof.

All bids must be accompanied by a Bid Security in the amount of Five Percent (5%) of the Total Bid Amount such guarantee to be forfeited should the bidder to whom the contract is awarded fails to execute and deliver a contract, in a prescribed form in accordance with the bid documents. Bid Security may be a Bid Bond, certified check or cashier checks, made payable to the Government of Kosrae State. If a check is provided it must be valid for at least one year. The bid bond of the winning bidder shall be retained as a Performance Bond and may be returned upon satisfactory completion of the project or earlier at the option of the contracting officer. Each bidder shall be skilled and regularly engage in the general class or type of work as called for. Each bidder must complete, sign and furnish the Bidder's Qualification Statement and other required documents along with the submission of the Bid Proposal. In submitting the bid proposals, the time duration for completing the project must be properly indicated. Contractor's bids without complying with the above requirements as well as other requirements mentioned in the Bid Documents shall be classified as non-responsive bids.

The Contract will be awarded to the lowest responsive/responsible bidder with the most favorable period of performance at the Owner's option identified in section III "Bid Proposal to the State of Kosrae for the at DREA Piggery Rehab Project". The State of Kosrae reserves the right to reject any or all bids and to waive any informality or irregularity in the bidding.
