A RESOLUTION

Expressing, on behalf of the people of Kosrae, their sincere gratitude and appreciation of the US Office of Insular Affairs, US Department of the Interior for making available a grant for Fiscal Year 2020 for funding in the amount of \$1,205,922 for construction of Kosrae Hospital Quarantine Building (24 units Isolation Room)

1           **WHEREAS,** the State of Kosrae still faces the risk of the COVID-19 pandemic of  
2 occurring within its boundaries and that appropriate measures still need to be continually  
3 implemented to alleviate such risk.

4           **WHEREAS,** a practical way to meet the risk of the COVID-19 pandemic occurring  
5 within its boundaries is the construction of a much needed quarantine building containing 24  
6 units isolation room within the Kosrae State Hospital compound.

7           **WHEREAS,** the Office of Insular Affairs of the US Department of the Interior has  
8 allocated a grant for the purpose of FSM Health Sector Grant COVID-19 Supplemental - Kosrae  
9 State COVID-3 to enable funding in the amount of \$1,205,922 to be made available in the  
10 Fiscal Year 2020 for the construction of the proposed Kosrae State Hospital Quarantine Building  
11 (24 units Isolation Room).

12           **WHEREAS,** members of the Twelfth Kosrae State Legislature appreciate the Office of  
13 Insular Affairs of the US Department of the Interior making available to the State of Kosrae the  
14 above-mentioned grant which will strategically assist the Kosrae State to promptly undertake a  
15 much needed practical way in counter acting the risk of COVID-19 occurring within its  
16 boundaries.
