11 increased risk of accidents from anti-social behavior and untoward conduct warranting the  
12 intervention of the police that could in turn cause injuries, damages, and death; and

13           **WHEREAS**, in the past recent years, the Division of Public Safety under the State's  
14 Attorney General's Office has organized extra staff including police officers to be made  
15 available to endeavor to minimize the risk of antisocial behavior and other untoward conduct that  
16 may warrant the intervention of police , especially during the Christmas and New Year holiday

7 Fourteenth Special Session, December, 2020, hereby urges Governor Sigrah to advise the  
8 Division of Public Safety under the State Attorney General's Office to organize extra staff  
9 including police officers to be made available especially during this holiday season, including  
10 Christmas and New Year; and
