

L. B. No. 13-138

A BILL FOR AN ACT

To appropriate the sum of \$40,000 from the Local Revenue Fund of the Kosrae State Treasury to supplement personnel budget for the Division of Public Safety, Kosrae State Government, for the fiscal year 2024; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$40,000 from the Local Revenue Fund of the
2 Kosrae State Treasury to supplement personnel and overtime budget for the Division of Public
3 Safety, Kosrae State Government, for fiscal year 2024.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
5 managed, administered and accounted for in accordance with applicable laws. The allottee of
6 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
7 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
8 which are appropriated and that no obligations are incurred in excess of the sum appropriated.


9 Section 3. Effective Date. This act shall become law upon approval by the Governor or
10 upon its becoming law without such approval.

11 PASSED BY THE 13TH KOSRAE STATE LEGISLATURE ON THE 5TH DAY OF JULY, 2024.
