



Section 1. <u>Appropriation</u> . The sum \$1,500.00 from	the Foreign Assistance	Fund of the

Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,

Kosrae State Treasury for the purpose of funding the Kosrae State Government New Production

- 5 managed, administered and accounted for in accordance with applicable laws. The allottee of
- the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
- ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
- 8 which are appropriated and that no obligations are incurred in excess of the sum appropriated.
- Section 3. Effective Date. This act shall become law upon approval by the Governor or
- 10 upon its becoming law without such approval.
