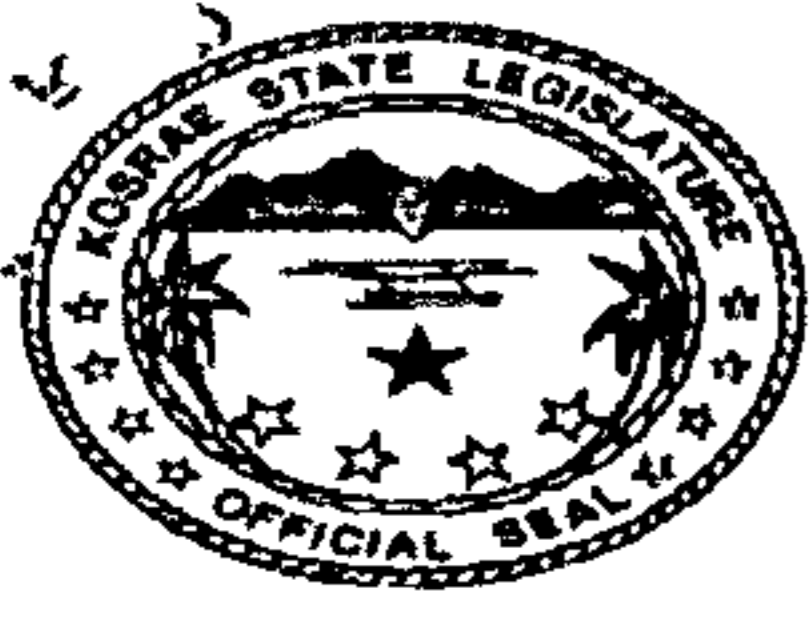



A BILL FOR AN ACT

To appropriate the sum of \$1,500.00 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose funding the Kosrae State Government New Production Development Fund; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum \$1,500.00 from the Foreign Assistance Fund of the  
2 Kosrae State Treasury for the purpose of funding the Kosrae State Government New Production  
3 Development Fund.

4           Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,  
5 managed, administered and accounted for in accordance with applicable laws. The allottee of  
6 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for  
7 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for  
8 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

9           Section 3. Effective Date. This act shall become law upon approval by the Governor or  
10 upon its becoming law without such approval.


