A RESOLUTION

Consenting to and confirming the nomination of Mrs. Sepe D. Mongkeya to serve as a member of the Kosrae Island Resources Management Authority Board.

1 **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution, the
2 Governor has the constitutional authority to appoint members comprising States Boards,
3 Authority, Commissions or Agencies with the advice and consent of the Legislature; and

4 **WHEREAS**, Section 7.401 of Title 7 of the Kosrae State Code established the Agency in
5 this chapter which shall be known as “Kosrae Island Resource Management Authority”; and

6 **WHEREAS**, Kosrae Island Resources Management Authority consist of five members
7 who serve terms of four years. Two of the members initially serve terms of two years and three
8 of the members initially serve terms of four years. Thereafter, all members serve terms of four
9 years; and

10 **WHEREAS**, by Governor’s Message No. 13 – 107, Governor Tulensa W. Palik has
11 nominated Mrs. Sepe D. Mongkeya to serve as a Board of Director for the Kosrae Island
12 Resources Management Authority; and

13 **WHEREAS**, the Speaker of the 13th Kosrae State Legislature has assigned Governor’s
14 Message No. 13-107 to the Committee on Environment, Transportation, Communication, and
15 Infrastructure in which the committee has deliberated and concluded its work on the nomination
16 of Mrs. Sepe D. Mongkeya; and

1 **WHEREAS**, the Standing Committee on Environment, Transportation, Communication,
2 and Infrastructure has been assigned to work on the nomination and has concluded its work on
3 the nomination of Mrs. Sepe D. Mongkeya; and

4 **WHEREAS**, it is the finding of the Standing Committee of Environment, Transportation,
5 Communication, and Infrastructure that the nominee is able to carry out the duties and
6 responsibilities of a board member of the Kosrae Island Resources Management Authority;

9 Sixth Special Session, November 2023, hereby consenting to and confirming the nomination of
