#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- 1 Section 1. Purpose. The purpose of this Act is to further amend State Law No. 13-
- 2 98, as amended by State Law Nos. 13-103, 3-112, 13-119, and 13-120, by amending
- 3 Section 2 at subsection (1)(c) to modify the Office of the Governor's FY2025 approved
- 4 budget for Contractual (additional \$6,000 for Governor and Lt. Governor's representation
- 5 fund at \$3,000 each) and \$20,000 for Travel.
