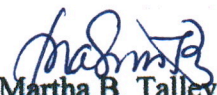

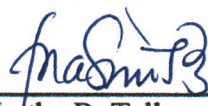

A BILL FOR AN ACT

To further amend State Law No. 13-98, as amended by State Law Nos. 13-103, 13-112, 13-119, and 13-120, by amending Section 2 at subsection (1)(c) to modify the Office of the Governor's FY2025 approved budget for Contractual and Travel; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to further amend State Law No. 13-
2 98, as amended by State Law Nos. 13-103, 3-112, 13-119, and 13-120, by amending
3 Section 2 at subsection (1)(c) to modify the Office of the Governor's FY2025 approved
4 budget for Contractual (additional \$6,000 for Governor and Lt. Governor's representation
5 fund at \$3,000 each) and \$20,000 for Travel.

6 Section 2. Amendment. State Law No. 13-98, Section 2 is hereby amended to
7 read as follows:

8 "Section 2. Apportionment. Operation of the Executive. The sums
9 apportioned by Section 1 of this Act are apportioned as follows:

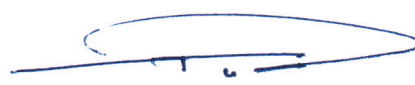
