A RESOLUTION

Consenting to and confirming the nomination of Mr. Snyder Simon to serve as the Attorney General for the State of Kosrae.

1 **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution
2 each principal department is under the supervision of the Governor and is headed by a
3 director. Directors are nominated and appointed by the Governor, with the advice and
4 consent of the Legislature, to serve at the pleasure of the Governor during his term of
5 office and until the appointment and qualification of their successors. Whenever a board,
6 commission or other body is the head of a principal department or a regulatory or quasi-
7 judicial agency, the members are nominated and appointed by the Governor with the
8 advice and consent of the Legislature. The term of office and removal of members are
9 prescribed by law.

11 **WHEREAS**, pursuant to Section 4.203, within sixty days of taking office
12 following election the Governor nominates a person to the directorship of a department;
13 and

14 **WHEREAS**, Section 5.201(6) of the Kosrae State code establishes the Office of
15 the Attorney General as a principal department; and

16 **WHEREAS**, through Governor's Message 12-67, the Honorable Carson K.
17 Sigrah, Governor of the State of Kosrae has nominated Mr. Snyder Simon to serve as the
18 Attorney General for the State of Kosrae; and

1 **WHEREAS**, the Standing Committee on Judiciary and Governmental Operations
2 has been assigned to work on the nomination and has concluded its work on the
3 nomination of Mr. Snyder Simon to the position of Attorney General for the State of
4 Kosrae; and

5 **WHEREAS**, it is the finding of the Standing Committee of Judiciary and
6 Governmental Operations that the nominee, as exhibited by his bio data, is qualified and
7 able to carry out the duties and functions of the Attorney General; **NOW THEREFORE**;

8 **BE IT RESOLVED**, that this Twelfth Kosrae State Legislature, on its Second
9 Regular Session, August 2019, consent to and confirm the nomination of Mr. Snyder
10 Simon to serve as the Attorney General for the State of Kosrae; and

11 **BE IT FURTHER RESOLVED**, that a certified copy of this resolution be
12 transmitted to the Honorable Carson K. Sigrah, Governor of the State of Kosrae; and to
13 Mr. Snyder Simon.
