A RESOLUTION

Setting forth the total funds estimated to be available from the United States Grant Fund, the Revenue Fund and the Foreign Assistance Fund for the fiscal year ending September 30, 2006, and requesting the Governor to notify the Legislature of any changes in the amount available from the funds of the Treasury.

1	WHEREAS, pursuant to the Kosrae State Code, Section 10.306, for each fiscal year the		
?	Legislature adopts a resolution stating the total funds estimated to be available for appropriation from		
3	each of the funds of the Treasury for the coming fiscal year, based on all available information; and		
4	WHEREAS, Kosrae State Code, Section 10.206, states that the United States Grant Fund		
5	contains all monies received from the United States Government, except United States federal agency		
6	program monies; and		
7	WHEREAS, Kosrae State Code, Section 10.205, states that the Revenue Fund contains all		
8	monies from the Government's collections through taxes, duty or tariff, and all other revenues or		
9	reimbursements from a fine, fee or license, interest, rent or services and other collections by a		
10	government for the Government's benefit, with certain exceptions; and		
11	WHEREAS, Kosrae State Code, Section 10.207, states that the Foreign Assistance Fund		
12	contains all monies not belonging to the Revenue Fund and received by the Government for its use from		
13	other governments, governmental agencies or other external sources other than the United States		
14	Government; and		
15	WHEREAS, the information available includes information from the Governor's estimates of		
16	the funds to be available as set forth in the budget submission, as well as estimates based on past		
17	experiences with the Foreign Assistance Fund; and		
18	WHEREAS, any estimates in the amount available from the Revenue Fund and other funds of		
19	the Treasury are subject to change; now, therefore		
20	BE IT RESOLVED, by the Eight Kosrae State Legislature that the total funds estimated to be		
21	available for appropriation from each of the funds of the Treasury are as follows:
