**A RESOLUTION**

Consenting to the re-nomination of Mr. Semeon J. Phillip to serve as a member of the Board of Directors for Kosrae Housing and Rural Development Authority.

1           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution, the  
2 Governor has the constitutional authority to appoint members comprising States Boards, or  
3 Commission with the advice and consent of the Legislature; and

4           **WHEREAS**, pursuant to Section 7.13075 of Title 7 of the Kosrae State Code, the Kosrae  
5 Housing and Rural Development Authority is governed by a five-member Board of Directors,  
6 who shall be appointed by the Governor with the advice and consent of the Legislature; and

7           **WHEREAS**, a member serves for a term of four (4) years, subject to reappointment, and  
8 until his successor has been appointed and qualified; and

9           **WHEREAS**, pursuant to Section 7.103 of Title 7 of the Kosrae State Code, a member of  
10 an agency's governing body takes office upon appointment by the Governor following the  
11 Legislature's consent by resolution to his nomination by the Governor; and

12           **WHEREAS**, by Governor Message 12-119, Honorable Governor Carson K. Sigrah has  
13 re-nominated Mr. Semeon J. Phillip to be a member of the Kosrae Housing and Rural  
14 Development Authority; and

15           **WHEREAS**, the Standing Committee on Resources and Development has been assigned  
16 to work on the nomination and has concluded its work on the re-nomination of Mr. Semeon J.  
17 Phillip to the Kosrae Housing and Rural Development Authority; and

3 the Kosrae Housing and Rural Development Authority; **NOW THEREFORE**


4           **BE IT RESOLVED**, that the Members of the 11th Kosrae State Legislature on the
