## A RESOLUTION

Concurring to Governor Sigrah's proposed amendments to the State Declaration of Emergency in response to the COVID-19 Pandemic.

1	WHEREAS, pursuant to Article V Section 13 of the Kosrae State Constitution
2	the Legislature shall convene at the call of the Speaker or the Governor to consider
3	revocation, amendment, or extension of the declaration, hence the official call for the
4	Eighteenth Special Session of the 12 <sup>th</sup> Kosrae State Legislature; and
5	WHEREAS, thru Governor's Message No. 12-296 dated July 29, 2021, this 12 <sup>th</sup>
6	Kosrae State Legislature was made aware of the Governor Sigrah's firm intent to amend
7	certain sections of the original State Declaration of Emergency, following the first
8	repatriation of 18 passenger arriving from Guam on July 19, 2021; and
9	WHEREAS, pursuant to Kosrae State's quarantine guidelines and SOPs, all 18
10	passengers were tested with PCR/ NAAT for SARS Cov 2, which has resulted with 17
11	negative and 1 positive case; and
12 13	WHEREAS, the single positive result case, which was later retested and found to be negative - a mere "footprint" of the virus, had alarmingly triggered a public panic for
14	the State, subsequently calling for Governor Sigrah's timely modifications to the original
15	State of Emergency Declaration;
16	WHEREAS, the proposed amendments were made possible through tireless
17	efforts, commitment, and close consultation with members of the State's COVID-19 Task
18	Force; and
