L. B. No. 13-203

A BILL FOR AN ACT

To appropriate the sum of \$15,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of providing funding assistance to the Kosrae Election Commission's most immediate State-held election, in support of a proposed referendum relating to the repealing of a recently amended Constitutional provision regarding a Senator's incapacitation and absence from duty station for six months; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$15,000.00 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the purpose of providing funding assistance to
3 the Kosrae Election Commission's most immediate State-held election, in support of a proposed
4 referendum relating to the repealing of a recently amended Constitutional provision regarding a
5 Senator's incapacitation and absence from duty station for six months.

6 Section 2. Apportionment. The amount shall be apportioned as follows:

7 1. Kosrae State Election/ Referendum Support \$15,000.00

8 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
9 managed, administered and accounted for in accordance with applicable laws. The allottee of
10 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
11 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
12 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

13 Section 4. Effective Date. This act shall become law upon approval by the Governor or
14 upon its becoming law without such approval.

BE IT ENACTED BY THE HOUSE OF REPRESENTATIVES

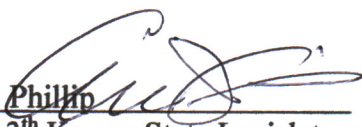
- 1 Section 1. Appropriation. The sum of \$12,000.00 is hereby appropriated from the Local
- 2 Revenue Fund of the Kansas State Treasury for the purpose of providing funding assistance to
- 3 the Kansas Election Commission's most immediate state-held election in support of a proposed
- 4 referendum relating to the repealing of a recently amended Constitutional provision regarding a
- 5 Senator's incapacitation and absence from duty station for six months.
- 6 Section 2. Apportionment. The amount shall be apportioned as follows:
- 7 1. Kansas State Election Return System Support \$12,000.00
- 8 Section 3. Allocation and Vesting Date. All funds appropriated by this act shall be allocated,
- 9 managed, administered and accounted for in accordance with applicable laws. The amount of
- 10 the fund appropriated shall be the Governor of the State of Kansas who shall be responsible for
- 11 ensuring that these funds or so much thereof as may be necessary are used for the purpose for
- 12 which are appropriated and that no obligations are incurred in excess of the sum appropriated.
- 13 Section 4. Effective Date. This act shall become law upon approval by the Governor or
- 14 upon its becoming law without such approval.

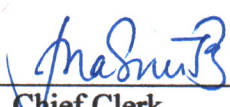
