A BILL FOR AN ACT

To appropriate the sum of \$1,500.00 from the Local Revenue Fund of the Kosrae State Treasury to fund Civil Case No. 2017-2001 – Stipulated Settlement and Judgment between Ricky L. Anton and the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$1,500.00 from the Local Revenue Fund of the
2 Kosrae State Treasury is appropriated to fund Civil Case No. 2017-2001- Stipulated Settlement
3 and Judgment between Ricky L. Anton and the State of Kosrae.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
5 managed, administered and accounted for in accordance with applicable laws. The allottee of
6 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
7 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
8 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

9 Section 3. Effective Date. This act shall become law upon approval by the Governor or
10 upon its becoming law without such approval.

12 JANUARY, 2024.
