A BILL FOR AN ACT

To amend State Law No. 12-120, by extending the lapse date of the Technical Assistant Program (TAP) grant for the Kosrae Auditor Training Programs; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to amend State Law No. 12-120, by  
2 extending the lapse date for the TAP grant for the Kosrae Auditor Training Programs.

3           Section 2. Amendment. State Law No. 12-120 is hereby amended to read as follows:

4                   “Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be  
5 allotted, managed, administered and accounted for in accordance with applicable laws.  
6 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who  
7 shall be responsible for ensuring that these funds, or so much thereof as may be  
8 necessary, are used for the purpose for which are appropriated and that no obligations are  
9 incurred in excess of the sum appropriated. The authority of the allottee to obligate funds  
10 appropriated by this act shall lapse on June 30, 2024.”

11           Section 3. Effective Date. This act shall become law upon approval by the Governor or  
12 upon its becoming law without such approval.


