A RESOLUTION

Consenting to and confirming the nomination of Reverend Timothy H. Jackson to serve as a member of the Kosrae Port Authority Board.

WHEREAS, pursuant to Section 12 of Article V of the Kosrae State Constitution, the
Governor has the constitutional authority to appoint members comprising States Boards,
Authority, Commissions or Agencies with the advice and consent of the Legislature; and
WHEREAS, Section 7.601 of the Kosrae State Code establishes the Kosrae State Port
Authority; and
WHEREAS, Section 7.606 of the Kosrae State Code further composes the Board of
Directors with five voting members. Four Directors; one from each the four Municipalities,
appointed by the Governor with the advice and consent of the Legislature, and, ex-officio, the
Director of the Department of Transportation and Infrastructure. An appointed Director serves

for a term of four years, subject to reappointment, and until his successor has been appointed and qualifies. Initially, the Governor appoints tow Directors to two-year terms and two Directors to four-year term; and

WHEREAS, by Governor's Message No. 13 – 103, Governor Tulensa W. Palik has nominated Reverend Timothy H. Jackson to be a member of the Kosrae Port Authority; and WHEREAS, the Speaker of the 13th Kosrae State Legislature has assigned Governor's Message No. 13-103 to the Committee on Environment, Transportation, Communication, and
