A BILL FOR AN ACT

Adding a new Chapter 17 to Title 12 of the Kosrae State Code relating to electronic smoking devices and electronic smoking substances; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Title 12 of the Kosrae State Code is amended by adding a new Chapter 2 17 thereto to read as follows: **"CHAPTER 17. ELECTRONIC SMOKING DEVICES AND SUBSTANCES** 3 Section 12.1701. Title. This chapter of the Code shall be known and may be cited 4 as "The Ban on Electronic Smoking Devices and Substances Act of 2019". 5 Section 12.1702. Definitions. As used in this chapter of the Code, unless context 6 7 clearly requires otherwise: 8 (1)"Electronic smoking devices" means any electronically powered 9 device that can be used to deliver aerosolized or vaporized nicotine to the person 10 inhaling from the device, including, but not limited to, an e-cigarette, e-cigar, vape 11 pen or e-hookah, and any component, part or accessory of the device, whether or not sold separately. 12 13 (2)"Electronic smoking substance" means any substance which includes nicotine or any derivative thereof and which is intended to be aerosolized 14

or vaporized during the use of an electronic smoking device.

1	(1) The offering for sale, sale, possession, or use of any electronic
2	smoking device as defined by Section 12.1702 (1) in the state of Kosrae is hereby
3	strictly prohibited.
4	(2) The offering for sale, sale, possession, or use of any electronic
5	smoking substance as defined by Section 12.1702 (2) in the state of Kosrae is
6	hereby strictly prohibited.
7	Section 12.1704. Penalties.
8	(1) Any person who knowingly and unlawfully offers for sale, sells,
9	possesses, or uses an electronic smoking device in violation of Section
10	12.1703(1) shall be guilty of an offense against the state of Kosrae, and
11	upon conviction thereof shall be imprisoned for a period of not more
12	than three months or fined not more than \$500, or both such fine and
13	imprisonment.
14	(2) Any person who knowingly and unlawfully offers for sale, sells,
15	possesses, or uses an electronic smoking substance in violation of
16	Section 12.1703(2) shall be guilty of an offense against the state of
17	Kosrae, and upon conviction thereof shall be imprisoned for a period of
18	not more than three months or fined not more than \$500, or both such
19	fine and imprisonment.

1	(3) Any electronic smoking device or electronic smoking substance offered
2	for sale, sold, possessed, or used in violation of this chapter of the Code
3	shall be forfeited to the state of Kosrae.
4	Section 12.1705. Surrender of devices and substances. Any person entering the
5	state of Kosrae through a port of entry who is in possession of an electronic
6	smoking device or an electronic smoking substance that is regulated by this
7	chapter of the Code shall surrender said electronic smoking device or electronic
8	smoking substance to an authorized officer of the Kosrae Port Authority and may
9	retrieve the regulated device or substance from the Kosrae Port Authority upon his
10	departure from the state of Kosrae."
11	Section 2. Effective Date. This act takes effect upon the approval of the Governor
12	or upon its becoming law without such approval; PROVIDED that the amendments to the
13	Kosrae State Code as set forth in this act shall take effect in December, 2019; PROVIDED
14	FURTHER that the Governor, with the assistance of the Director of the Department of
15	Health Services, shall provide for a public information program with respect to the
16	amendments to the Kosrae State Code set forth in this act prior to said date.
