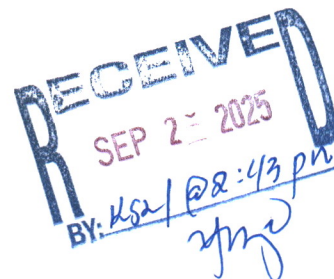

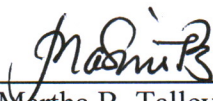

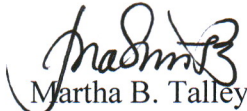

A BILL FOR AN ACT

To appropriate the sum of \$5,000.00 from the Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2026 for the purpose of providing funding assistance to Kosrae Lawn Tennis Association for hosting of the first “Play Tennis Course” in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1       Section 1. Appropriation. The sum of \$5,000.00 is hereby appropriated from the  
2       Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2026  
3       for the purpose of providing funding assistance to Kosrae Lawn Tennis Association for  
4       hosting of the first “Play Tennis Course” in the state of Kosrae.

5       Section 2. Apportionment. The amount appropriated in Section 1 of this act is  
6       apporttioned as follows:

7       1. Kosrae Lawn Tennis Association .....\$5,000.00

8       Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
9       administered, and accounted for in accordance with applicable laws. The allottee of the  
10      funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible  
11      for ensuring that these funds, or so much thereof as may be necessary, are used for the  
12      purpose for which are appropriated and that no obligations are incurred in excess of the sum  
13      appropriated.

14      Section 4. Effective Date. This act takes effect upon the approval of the Governor  
15      or upon its becoming law without such approval.

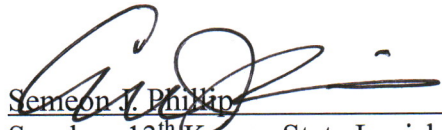

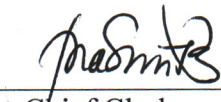
