A RESOLUTION

Expressing the Thirteenth Kosrae State Legislature's utmost sincere gratitude and appreciation to Kosrae Utilities Authority (KUA) Management and Personnel for their professionalism in restoring and reviving the time period of electrical fluctuation and power outage.

WHEREAS, pursuant to Section 7.1202 of the Kosrae State Code, the Authority is vested with the following powers, duties and responsibilities: To provide to the public electric power, referred to in this chapter as "Authority services". To operate and manage the State's 3 electric power, wastewater and water system services, on the basis of commercially accepted 4 practices, treating all users of Authority services on equitable terms in accordance with its published fees and requiring all users to pay for services rendered. To expand and improve upon 6 services offered to the public, and, where practicable, construct and operate new facilities to meet the foreseeable demand for Authority services. To acquire and maintain from the revenues 8 and subsidies received by the Authority, a prudent contingency reserve or program of insurance, 9 10 including liability coverage, for all personnel, facilities, and equipment controlled by the Authority. To invest all surplus revenues of the Authority in the expansion and improvement of 11 Authority service; and 12 13 WHEREAS, the State of Kosrae faced a time period experiencing electrical fluctuations 14 and power outage throughout the island, from the month of December 2023 to January 2024, due 15 to malfunctions and technical problems to the power generators, resulted in some sections of Kosrae State experiencing the power outage more than a month; and 16
